PSLRA Membership Meeting

August 4, 2018

The meeting was called to order at 4:45 PM. Board, General Members & Guests in attendance included: Becky Dannaker, Diane Sullenberger, Sharon Edwards, Missy Bendzak, Angela Rogalla, Nina Mann, Julie Kirk, Katie Somers, Laura Reich, Shirley Trotter, Barb Pilkington, Mark Pilkington, Diann Sullivan, Marcy Johnson, Kristi Clark, Chantel Nahoopi, Michelle Brown, Lucy Isaacson Logen, Jill Mahoney, Allison Rogers, Colleen Doll, Dana Richmond, Buffie Gonzales, Sonya Dudder, Scott Dannaker, Cindy Deibg, Marlys Swanson, Ramdas Vaidyanathan.

The hunt test is coming up. Some decisions need to be made and following are the options (the Board is open to any alternate ideas).

- Option 1 – If we have a WC it will have to be run after Juniors around 3pm and that will make for a very long day, therefore doesn't seem possible.
- Option 2 – Someone house the ducks and pigeons from August 25th to September 8th.
- Option 3 – Someone goes to Omac and picks up the birds on September 7th.
- Option 4 – We have a fun field day and people bring frozen ducks.

Treasurers Report – This information is not printed in the newsletter, but it is always available from the treasurer.

Survey – Jill was looking for direction from the club from the online survey. The one survey opinion revealed the board makes decisions for the club without the general membership. It was pointed out at this meeting the board was elected by the membership to act on behalf of the club and making decisions for the club is part of the responsibility.

The AKC requires the Club to have five members at an event in case we require a disciplinary committee meeting. The Committee Chairs and additional volunteers should make the five people. Shift work is an option to fulfill this requirement.

The survey also revealed many liked the health clinic finding it smooth running with good doctors. It was asked if we could possibly do more litters?

Of the 42 survey responses, 13 were board members.

Marcy Johnson had previously suggested we investigate the possibility of having some of our board of directors' meetings online via Zoom. It's less expensive than the teleconferencing and easy to utilize. Stephanie verified with AKC rules and this form of meeting method meets approval. The board has met via Zoom several times and the response has been positive.

It was suggested that the obedience trial move to one day at the specialty, with two separate trials starting at 8am and the other at 11am. This will be discussed in the committee and at the board meeting. Feed-back is welcome, please contact Jill, Chantel or Kristi prior to the August 15th board of directors meeting.

Jill has proposed in the very near future we rename the Membership Award to the Ron Perry Memorial Membership Award. Ron was a shining example of a PSLRA Member. He dedicated himself to our club through leadership and participation in "all" our events. Ram suggested that we put a limit to the name of the Ron Perry Memorial Membership Award to ten years. After that, that the name can change to recognize another member who has contributed extensively to the club, but has passed away in the intervening period.

Sonya Dudder reported that she and Diane are looking into changing the Banquet location to The Ram in Puyallup. The Ram offers a room to rent for \$50, the food options are better, and it costs substantially less. They welcome suggestions for a speaker.

Cheri Wildes has been researching a service similar to Labchat. It has been suggested that we can leave Lab Chat for a better online service that goes through our web site, which is similar to a forum.

We are also looking to go paperless with the membership book and have it available through our web site online. This will save the club a huge expense of printing and mailing.

Colleen suggested that we widen our acknowledgement of Juniors to include them in our "supported entry shows" like Puyallup. Shelah Frey is our representative for the Puyallup Shows. The Policy Committee will research our bylaws checking on specific club rules.

Colleen and Marcy suggested putting together a mentor list. Members could call for advice and help in all areas of our club and with Labradors and it would be limited to non-veterinary issues. Several people expressed an interest in being a mentor

Mary Jane and Sonya asked the attending members what they thought of the new site. A resounding applause and cheers of approval followed. The comments were very positive. The lower temperature was a welcome relief for our dogs. The camp sites around the ring were shaded and spacious. The local area offers lots of sites to see from Deception Pass to an Art Festival. Allison said it is wonderful having the Puget Sound Club holding our show in the heart of the beautiful Puget Sound in a park overlooking the water. This location gave our visitors a true taste of the Pacific Northwest. There was no further discussion. The meeting was adjourned at 5:30pm and dinner was served.

PSLRA Board of Directors' Meeting Minutes

August 15, 2018

The meeting was called to order at 6:39pm. Board and Committee members present included Jill Mahoney, Jen Hajny, Mary Jane Sarbaugh, Kristen Reiter, Ram Vaidyanathan, Marlys Swanson, Shelah Frey, Katie Somers, Linda Maffett, Jim and Cindy Olson, Stephanie Harris, Becky Dannaker, Marcy Johnson, Sonya Dudder and Diane Sullenberger. Scott Dannaker, Nina Mann and Brenda Hubbard all had excused absences.

Jill provided the President's report. She thanked the board members for their involvement, service and leadership. She is incredibly proud of the group of members who make up this club and commends the leaders who organized and hosted a fabulous Specialty event.

Jenn has committee chairperson concerns and updates that she will address throughout the meeting.

Kris has received signed contracts back from the hunt test judges.

MJ presented the treasurer's report which is available to the membership per request.

Acknowledgements are needed for the Specialty. Linda Maffett and Angela Rogalla will compile a list of chairpersons and volunteers from the Specialty and MJ will compile a list of volunteers for the hospitality booth.

Linda reported on the Specialty. The new venue was well-received, and the Parks department said we were great guests. The Specialty committee is reviewing the event and considering improvements to be made. Parking was limited and could be improved through better utilization of the campsites. The grass was dry, but it wouldn't take much to place a sprinkler out a few times the week prior to the show to help hydrate it. The venue was cooler than the other previous venues have been – there were moments where the air would grow warm, but then a breeze would blow and cool everything down. Angela has scheduled a debriefing to troubleshoot issues and highlight benefits of the venue.

Jenn reported for the Specialty obedience committee. The number of entries has dropped. The response from the obedience competitors is that they loved the site. One exhibitor had an issue with the ring placement. Chantel informed her that it could be moved if she wanted to move it, so it remained in its original location. There were some issues with odors within the ring and several dogs were disqualified for neglecting their exercises due to sniffing. The exhibitors still felt walled off from the remainder of the show rings. It was stated in the meeting that isolating the ring was intentional, in an effort to reduce the distractions for the obedience entrants. Chantel did a great job checking in with the judge, stewards and exhibitors and the winners appreciated their prizes.

Jim Olson reported on the Hunt Test. They are still looking for volunteers. The entries are higher than they were in May. This should offset the fee increase for use of the land. Pepper's has sold and is now known as the Snoqualmie Valley Retriever Grounds. We need to identify who we make the payments to and how. The budget mirrors the budget for May's test. Jim scored a deal on ammunition, so he purchased it for the club and will send a receipt to MJ for reimbursement.

The Health Clinic is proceeding as planned. Some people have already sent in forms. MJ has provided Kris an updated flyer for the newsletter as the previous one listed an inaccurate date.

Katie reported on the supported entry in Wenatchee. Anne Maynard has already been chosen as the judge for 2020. Camping will be available and includes full hookups. The Labradors will all be camping in the same "neighborhood." Be aware that it can get muddy with rain, but so far, the venue has been dry.

Jill has not received a report on the Fall Agility Trial. She did contact Kristy and informed her that a response is required. She was instructed to report within a week.

The Hunt Test budget was presented. The judges are local, so we save money on hotels and travel. MJ made a motion to approve the budget as presented for the Fall Hunt Test. Diane seconded the motion and there were no opposed. The budget was approved. Cindy Olson will inform Liz Gibson of the decision.

Shelah reported on the January supported entry. There will be prizes for conformation, highest scoring Labrador in obedience and highest scoring Junior handler. At this point, the rules state that Juniors must be showing a Labrador, so our awards for Juniors will be "Highest Scoring Junior with a Labrador."

Sonya reported that The Ram restaurant has been chosen as our site for the banquet, however they are not accepting reservations this far in advance. We won't be able to make a reservation until November or December.

At the membership meeting, there was discussion on the Junior members, namely identifying methods to get them more involved. A committee is needed, not at the board level, to find ways to engage the youth and provide support. Discussion ensued on supporting Junior handlers at the shows. Marcy suggested that all-breed clubs should support all Junior handlers, but a specialty breed club such as PSLRA should support only Juniors showing our breed of choice. MJ stated that we should support Juniors in *all* events (obedience, hunt tests, Junior handling, conformation), but that they should show a Labrador. Ram expressed concerns about regulating the awards if they are presented to all-breed competitors. Becky advised we should support the youth, regardless of the breed they show in order to propagate the sport in general. Kris added to this by stating that today's Junior handler is tomorrow's professional - be it a show handler, trainer, breeder, or even a veterinarian – who could benefit our breed in one way or another. Becky made a motion to award \$25 to the Best Junior Handler at the three PSLRA supported entry shows. Shelah seconded the motion. The money to fund the awards will come from the Junior's fund. A tally of the votes resulted in seven for and six against. With the majority being in favor of the proposal, the motion was passed and will take effect at the 2019 shows. It was suggested that the club should offer an additional award for a Junior who is showing a Labrador. Katie offered to monitor the Wenatchee supported entry for Junior Labrador entries. MJ made a motion that any Junior participant showing a Labrador in Junior showmanship, rally or obedience shall be awarded \$10 at any of the 2019 PSLRA supported entry shows. Jenn seconded the motion. There were no opposed and the motion passed unanimously.

The survey discussion was tabled until the next meeting due to time and the need to review the responses.

Kris reported on the newsletter. Any board members who have not submitted their bios are encouraged to send them in as soon as possible.

PSLRA Board of Directors' Meeting—Continued

Marcy reported on the Junior Handler Auction. The event was successful. The stud dog portion was an awesome fundraiser and the quilts were very well-received. It would be great to get the kids more involved. One suggestion was to have the kids judge the adults as handlers.

Due to Nina's absence, it is unknown if the medallions have been ordered. MJ has not seen a bill for the order yet, so she will contact Nina for an update.

The membership book printing has been delayed due to a communication glitch. Jill suggested putting the book online with a password protection. It can be sent out as a PDF to member emails just as we send our newsletters. It would save the club printing fees and mailing costs. Brenda is unavailable to report due to an excused absence, but if the books have not been printed yet, this is a viable option. Sonya made a motion to send out an electronic version of our membership book in lieu of a printed version. MJ seconded this motion. The majority were in favor and the motion carried.

Pepper's has a new owner. William Hart called Jill to inform her that he had purchased Pepper's. She directed him to Cindy and Jim Olson and Liz Gibson. He was extremely nice and wants to work with us. He assured us that everything will remain the same as he does not intend to make any big changes.

Argus is not sold yet, but it is for sale. We do have a deposit submitted for the Fall Agility trial. The availability for any future events is unknown.

Diane Clark is our new Master National representative.

The issues we've been having with some of our event chairs was discussed. The Fall Agility trial committee has not submitted judges' names for approval, nor has the board seen a budget. Despite multiple attempts, Jenn has been unsuccessful in communication. According to our bylaws, the judges must be approved by the board.

MJ requested to revisit the Junior handler awards as we neglected to provide recognition to those Juniors who partake in Hunt Tests. Jim offered that there are not many Junior handlers in the hunt fields, perhaps only four over the past five years, but we can offer something to encourage participation. There may be one Junior handler entered in the Fall Hunt test coming up. MJ made a motion to award a \$10 gift card to any Junior participating in Hunt Tests. Jenn seconded the motion. The majority of the board members were in favor, with one against. The motion carried.

New business was discussed.

Chantel and Kristy are suggesting that we combine our two days of Specialty obedience trials into a single day of competition. This will require the services of only one judge on a single day, thus reducing hotel fees, daily expenses and judging fees to the tune of ~\$500. At the recommendation of the Specialty Obedience Committee, a motion was proposed to move our performance trial to a one-day show with two obedience and two rally trials. All board members were in favor and the motion carried. Jill will inform Chantel.

Lizzie Moir distributed a letter to all board members providing criticism of Bay View Park as the Specialty venue and the process for choosing the site. The letter requested access to the Specialty's financial statements as well. The previous Specialty site in Enumclaw had its issues, namely its 98-degree temperatures. The members debated attendance due to the extreme heat, there was a concern for the safety of the exhibitors, judges and dogs and extraordinary measures were taken to ensure there were no heat-related health issues. These issues prompted the show committee to consider other venues. The Bay View State Park (as well as other venues) may have been campaigned, but there was no decision to move the Specialty until November after venue research concluded and member opinions were considered. The Bay View State Park was chosen based upon the research and recommendation of the Specialty committee. As with any new venue, there are areas for improvement as suggested in Ms. Moir's letter. The Specialty committee is already addressing the concerns raised about the venue and troubleshooting methods for improving upon the grounds. The two biggest issues (as mentioned previously in the meeting) were parking and the dry grass, and the committee is already finding solutions to those issues. Unfortunately, the complaint about campsite size and lack of direct water view are characteristics that we cannot change. Kris will send a letter to Ms. Moir to thank her for her input. A copy of the financials will be made available to her, as requested, in early September.

At the recommendation of the Specialty committee chairpersons, Ram made a motion that the 2019 PSLRA Specialty be held at the Bay View State Park. Marcy seconded the motion and all other board members were in favor. The motion was approved.


The next board of directors meeting will be held September 19th at the IHop in Issaquah at 6:30pm. As always, members are invited to attend.

The Working Certificate is scheduled for September 8th. Unfortunately, there have been issues in obtaining birds or finding someone to care for them between the Hunt Test and the Working Certificate. The Evergreen Golden Retriever Club is hosting a WC and is willing to share the grounds, but they can only handle a limited number of Labs and the Labs would run after the Golden Retrievers have concluded. They would not offer pre-registration, and limited entries could mean that a participant shows up but is not allowed to run. We would have to pay \$60 to split the cost of the portapotty and the participants would be charged \$50/dog entry to cover bird expenses and fees. They would prefer that we could provide some volunteers to assist as well. It would be September 22nd, the same week as our health clinic. There is concern about losing gunners and participants due to the lateness of the season and the start of goose hunting. If we join up with the Golden Retriever club, it isn't our event any more. It seems there are too many negative issues to pursue a combined effort with the Golden Retriever Club. Jenn made a motion that, due to the difficulty obtaining birds, we cancel the PSLRA WC originally scheduled for September 8, 2018. Shelah seconded the motion and it was approved unanimously. Shelah will call Jenny Leach and cancel the reservation for the grounds.

The meeting was adjourned at 9:06pm.




PSLRA Specialty—PeeWee Showmanship





Her own experience includes 10 Obedience Trial Champions (OTCH), 2 Field Champions (FC), 4 Amateur Field Champions (AFC), a UDT Maltese and a CDX Shih-Tzu. Connie's Golden, "Eli" and her Labrador, "Ezra" were the first retrievers to earn an obedience trial championship, a field championship and an Amateur field championship. Connie is also the owner of Dog Trainers Workshop, a full-service dog training and boarding facility near Greenville, SC. Dog Trainers Workshop features an array of classes, day and boarding schools, and private lessons for puppy owners, those starting out in obedience training, obedience competitors, and owners with problem dogs.

As important as Connie's achievements in training her own dogs is her passion for teaching others. At Dog Trainers Workshop Connie teaches obedience to more than 100 students each week. She conducts several webinars a year and has developed digital training products addressing puppy training, ring preparation, proofing and tricks that transition to obedience exercises.
