



Nominating Committee News

PSLRA elections are coming up for the 2019 slate of Directors and Officers. As announced in the October newsletter, the nominating committee consists of Chairman Cindy Olson, Jennifer Hajny, and Cheri Levine. Please feel free to contact any of the nominating committee if you are interested in becoming a PSLRA Director or Officer for 2019.

According to PSLRA's By-Laws, the Board (BOD) shall be comprised of the President, Vice-President, Secretary, Treasurer and at least eight other persons who shall be members in good standing and whom shall be elected at the Club's annual meeting in January. The 2018 Board, Directors and Officers, consisted of 17 members which is five more members than are required according to the By-Laws. At this time six current members will not be running for re-election and one member is still undecided. In our recent survey there were several comments relating to our BOD and the general management of the Club's affairs. As Chairman of the nominating committee I would like to share some of these comments and I will look to all of the PSLRA membership for comments:

Reduce the number of BOD members - for 2019 we intend to fill the required 12 member BOD but will add additional positions if members step forward

Reduce the number of meetings - the By-Laws call for six member meetings per year. As it stands currently, two of these are for the holiday party in December and the annual meeting in January. In 2018 there were 12 planned BOD meetings and we are looking to reduce this to four quarterly meetings noting that BOD meetings and other special meeting can be called as needed.

Term Limits for BOD members - currently only Officers have term limits. Directors may serve until they decide not to run for re-election.

Limit the number of Directors who represent one venue - I understand that the returning BOD members represent more of the conformation and obedience venues so we are looking for new BOD members to represent agility, field and tracking.

The BOD are too controlling and new opinions will not be heard - what better time to influence the direction that PSLRA will be taking in 2019 and beyond than by becoming part of the general management of the Club's affairs.

Some of the above comments from the survey would seem to require an update to the underlying organizational documents on which PSLRA was founded. Specifically the Constitution and By-Laws, Club Policies and Standards and the PSLRA Code of Ethics. Perhaps now is the time to look at these documents and to update them for the future. Other items can be addressed by taking a more active role in the organization by becoming a Board member and facilitating the management of the Club's affairs.

The members of this year's nominating committee are very supportive of the idea of having BOD members that will promote the All Around Labrador. To accomplish that end, we need members to champion all of the venues PSLRA supports: Agility, Conformation, Field, Obedience, Scent Work and Therapy even if that means a BOD of more than 12 members. Please let me know if you would like to be nominated to the 2019 PSLRA Board of Directors.

Nominating Committee News

DEADLINE: Upon receipt of the Nominating Committee's report, the Secretary shall, before November 15th, notify each member in writing of the candidates so nominated

DEADLINE FOR LATE NOMINATIONS: Additional nominations may be made at the December meeting by any member in attendance provided that the person so nominated accepts when his name is proposed, and provided further that if the proposed candidate is not in attendance at this meeting, his or her proposer shall present to the Secretary a written statement from the proposed candidate signifying his or her willingness to be a candidate.








PSLRA Website Tips



After the Member features were launched, many Club Members logged on to the site, changed their password as requested, and either forgot they did so, or forgot the password.

To make purchases, including Membership Renewal Payments, Members MUST be logged on to the system.

Please review the tips below for instructions for how to resolve this, and other common Club website issues:

Keep Me Signed In: Did you know if Members log on to the Club's website and check the Keep Me Signed In box, they stay logged on until they choose to log out in the future?

This allows Members to access the site with full Member benefits without needing to log on again.

If Members remain logged into the site, they can simply click the Newsletter provided in the Club's email campaign, (as well as any other the links), and go directly to the posted Newsletter PDF and start enjoying the latest issue. Give it a try!

I Forgot My Password: If a Member forgets their User Name or Password for the site, the best way to resolve the issue is to do the following:

- Go to the Member drop-down on the upper right of the web page.
- Choose the Password Reset option in the drop-down menu.
- Include the User Name or email address.
- Using an email address is probably easier.
- The system will email a link to reset the password.

Reset the password, log-in, and choose the checkbox Keep Me Signed In.

Member Log-in for Site Purchases: As part of the set up for the Member's Only Features, All Club Members technically have two accounts and are considered a Customer and a Member.

Since the site views all Members as Customers and all Member information is already in the system, Members will experience the following when attempting to make a purchase through the system if logged on, versus NOT.

- If a Member chose the Keep Me Signed In checkbox during their previous log in, the cart will recognize them as a Member and they can check out with no issues.
- If a Member attempts to check out without logging in, after manually inputting their information into the cart, the cart will recognize they are a Member and require them to log in.

There is a link to log in at the top of the cart checkout page. If the member knows their User Name and Password, and they log-in, they will proceed through check out without an issue.

The Club's website is no different than any other site a Member may have an account with, e.g., Facebook, Amazon, the Lab Chat, etc. Members simply log on and choose to Keep Signed In. In the future when they visit, they will have access to all Member features because the site will automatically recognize them a Member/Account Owner.

Reminder: PSLRA 2019 Membership Renewal - Please Renew by 1/12/2019



As mentioned in Jill's President's Letter in the 2018 December Newsletter we are requesting that all current Members wishing to renew their PSLRA membership in 2019 do so by January 12, 2019.

Lifetime Only Members: If you are a Lifetime Member (meaning a Member for the past 25 consecutive years/since 1993) who is NOT a current member of the Breeder List/Directory, you DO NOT have to make a membership renewal payment through the Club's shopping cart.

Current Breeder List/Directory Members including Lifetime Breeder List Members:

All Members who are currently a member of the Breeder List/Directory can renew their membership and pay for their 2019 Breeder Directory Listing as one transaction.

This payment option is located here <https://www.pslra.org/product/membership-renewal-breeder-directory/> and you must be a current Breeder List Member and logged on to the site to access it.

If you are a Lifetime Member who IS a current member of the Breeder List/Directory and want to remain on the list for 2019 you DO have to make a Breeder List/Directory payment ONLY.

Lifetime + Breeder Directory Payment Option: Select the Breeder List \$15.00 + Lifetime Membership \$0 = \$15.00 option from the drop-down list. Upon checkout you can choose to pay by Check or PayPal.

All Non-Lifetime Members Individual or Family (No Breeder Directory/Listing):

This payment renewal option is located here <https://www.pslra.org/product/standard-membership-renewal/> and you must be a current Family, Individual or Junior Member and logged on to the site to access it. Upon checkout you can choose to pay by Check or PayPal.

By using the Club's shopping cart to process your renewal payment, the Club will have a record of your 2019 renewal. No other forms are required.

Club Member Profile Updates & On-Line Directory:

All Members, regardless of type are asked to log on to the site and add any missing information in their Member Profile to automatically populate their Member Information in the Club's On-line Directory.

- Your personal Labradors are welcome to attend/participant in the booth and must be at least 6 months of age to be present at the event.
- Dogs must be well socialized/mannered, with both people and other dogs.
 - The show is attended by many people of all ages, including families with small children who will want to pet your dog.
 - Other dogs may be present in the PSLRA Educational Booth, so dogs need to be comfortable interacting with dogs they may not know.
- Chairs will be provided in the booth, as well as a large crate for dogs to use while their owner is volunteering.
- Please bring any snacks or drinks you and your dog may need during your volunteer assignment.
- **Canine Influenza (CI):** Please be aware that Canine Influenza or Dog Flu, is a highly contagious viral infection affecting dogs. Dogs in close contact with infected dogs in places such as kennels, groomers, day care facilities, performance events, etc. are at increased risk of infection.
